Regular auction for 12 weeks maturity Government Treasury bill was announced at face value of 10 billion MNT and each unit was worth 1 million MNT. Face value of 10 billion /out of 20.0 billion bid/ Government Treasury bill was sold to the banks at discounted price and with weighted average yield of 8.40%.
