Regular auction for 12 weeks maturity Government Treasury bill was announced at face value of 30 billion MNT and each unit was worth 1 million MNT. Face value of 30 billion /out of 35.0 billion bid/ Government Treasury bill was sold to the banks at discounted price and with weighted average yield of 8.10%.
