Regular auction for **12** weeks maturity Government Treasury bill was announced at face value of **50.0** billion MNT and each unit was worth **1** million MNT. Face value of **50.0** billion /out of **77.0** billion bid/ Government Treasury bill was sold to the banks at discounted price and with weighted average yield of **10.35%**.
