1 The Government of Mongolia has received a loan from the Asian Development Bank (ADB) toward the cost of **Payment System Modernization Project**, and it intends to apply part of the proceeds of this loan to payments under the Contract for procurement of **NETC Core network devices, NETC/Goods /2016 -019**.

2 The **Bank of Mongolia (BOM)** now invites sealed Bids from eligible Bidders for supply of **Core network devices (Routers, Switches, Next Generation Firewalls) at the National Electronic Transaction Center of BOM**.

3 **National competitive bidding** will be conducted in accordance with ADB's [Single-Stage: One-Envelope](#) procedure and is open to all Bidders from eligible source countries.

4 Interested eligible Bidders may obtain further information from the Project Implementation Unit (PIU) of PSMP and inspect the Bidding Document at the address given below, during office hours from 09:00 hours to 17:00 hours (Ulaanbaatar time) excluding Saturday, Sunday and Holidays.

5 The Bidding Document, in Mongolian language, may be purchased by interested Bidders upon submission of a written application to the address below and upon payment of a nonrefundable fee **MNT 50,000** or in an equivalent amount in a freely convertible currency. The method of payment will be direct deposit to account No. 109000067145 of the State Bank of Mongolia. The document will be sent by airmail for overseas delivery for an additional MNT 150,000 and surface mail or courier for local delivery. No liability will be accepted for loss or late delivery.

6 Bids must be delivered to the address below **on or before 15:00 hours of Ulaanbaatar time (GMT+8) on 21 December 2016**. All Bids must be accompanied by a Bid Security as described in the Bidding Document. Late bids shall be rejected. Bids will be opened immediately in the presence of the Bidders' representatives who choose to attend at the address below at 15:00 hours of Ulaanbaatar time (GMT+8) on 21 December 2016:
